

**WEST PIKELAND TOWNSHIP  
ORDINANCE NO. 92-01**

**AN ORDINANCE AMENDING SECTION P-1503.8 OF THE  
BOCA NATIONAL PLUMBING CODE/1984**

WHEREAS, the Board of supervisors is cognizant of Resolution No. 88-2, an amendment to the Comprehensive Plan and Water Code of the Delaware River Basin in relation to water conservation performance standards for plumbing fixtures and fittings:

WHEREAS, this amendment requires that all municipalities within the Delaware River Basin adopt these performance standards;

AND NOW, THEREFORE, this 6<sup>th</sup> day of April 1992 be it enacted and ordained and it is hereby enacted and ordained by the Board of West Pikeland Township that:

Section P-1503.8 of the BOCA National Plumbing Code/1984 is hereby amended to include the water conservation provisions of Delaware River Basin Comprehensive Plan Resolution 88-2 as revised, subsection 2.1.5 a copy of which is attached to and made part of this Ordinance. Any conflicting requirements concerning Water Conservation that are contained in the BOCA National Plumbing Code/1984 as amended are hereby repealed.

Except as amended here, all other sections of the BOCA National Plumbing Code 1984 as amended are hereby ratified and confirmed.

This Ordinance shall become effective five (5) days after the adoption thereof.
