ORDINANCE NO. 2001-12-3

AN ORDINANCE OF THE TOWNSHIP OF WEST PIKELAND, CHESTER COUNTY, PENNSYLVANIA, REDUCING THE MAXIMUM SPEED LIMIT ON HORSESHOE TRAIL THROUGHOUT WEST PIKELAND TOWNSHIP TO TWENTY-FIVE (25) MILES PER HOUR

WHEREAS, the Board of Supervisors of West Pikeland Township is authorized by the Pennsylvania Vehicle Code to establish maximum speed limits on roads under its jurisdiction; and

WHEREAS, the Board of Supervisors of West Pikeland Township is authorized to establish a twenty-five (25) mile per hour maximum speed limit on roads within its jurisdiction located in a residence district if the road is not a numbered traffic route and is functionally classified by the Pennsylvania Department of Transportation as a local highway, pursuant to Section 3362(a)(1.2) of the Pennsylvania Vehicle Code; and

WHEREAS, Horseshoe Trail is a local road under the jurisdiction of West Pikeland Township, is located in a residence district, is not a numbered traffic route and is functionally classified by the Pennsylvania Department of Transportation as a local highway; and

WHEREAS, the Board of Supervisors of West Pikeland Township desires to establish a maximum speed limit of twenty-five (25) miles per hour on Horseshoe Trail throughout West Pikeland Township pursuant to Section 3362(a)(1.2) of the Pennsylvania Vehicle Code in the best interests of the health, safety and welfare of the traveling public and the residents of West Pikeland Township;

NOW, THEREFORE, be it, and it is hereby **ORDAINED** by the Board of Supervisors of West Pikeland Township, Chester County, Pennsylvania, and it is hereby **ENACTED** and **ORDAINED** by authority of same as follows:

1. The maximum speed limit at all times on Horseshoe Trail is hereby established to be twenty-five (25) miles per hour.

2. The appropriate officials and/or employees of West Pikeland Township are hereby authorized to erect the appropriate traffic control devices in order to enforce the twenty-five (25) mile per hour maximum speed limit on Horseshoe Trail throughout West Pikeland Township. This Ordinance shall be enforceable by the West Pikeland Township Police Department.
