AN ORDINANCE AUTHORIZING WEST PIKELAND TOWNSHIP  
TO ENTER INTO AN INTERGOVERNMENTAL COOPERATION  
AGREEMENT WITH THE FOLLOWING MUNICIPALITIES:

2. CALN TOWNSHIP
3. CITY OF COATESVILLE
4. EAST BRANDYWINE TOWNSHIP

14. WEST PIKELAND TOWNSHIP

ALL OF WHICH ARE LOCATED IN CHESTER COUNTY,  
PENNSYLVANIA, FOR THE PURPOSE OF INITIALLY ENTERING INTO  
AN AGREEMENT WITH LEGAL COUNSEL TO NEGOTIATE WITH  
VERIZON FOR A FRANCHISE AGREEMENT AND FOR ANY OTHER  
PURPOSE DEEMED NECESSARY AND BENEFICIAL BY THE  
MUNICIPALITY.

West Pikeland Township, Chester County, Pennsylvania, hereby ordains as follows:

1. The Township authorizes the proper officers of West Pikeland Township to enter into an Intergovernmental Cooperation Agreement with the aforementioned municipalities.
2. The aforesaid agreement shall continue until revoked by actions by each respective municipality participating in said agreement.

3. The purpose and objectives of the agreement is to facilitate proposals, agreements, cooperative actions and to promote the health, safety and welfare of the participating municipalities with the least expenditure on behalf of the participating municipalities.
4. The agreement shall be financed by the use of proper funds of the participating Municipalities as permitted by Code.
5. Each Municipality will designate a representative to implement the agreement.
