- b. Environmental Advisory Committee (EAC) Report
  - i. Working to get junior EAC members involved (under the age of 18 yrs old)
  - ii. Invasive Autumn/Russian Olives near creek over growing onto the tree tubes.
    - 1. Invasive species are allowed to be removed per the Natural Lands Trust per email documentation.
    - 2. Would need a certified herbicide applicator (township employee) to cut shrub and then apply to open cut.
      - a. Best time would be August/September time frame.
      - b. Herbicide to use: Triclopyr (\$145/2.5 gallons. Would budget \$400)
        - i. Parks and Rec approves \$200 for Triclopyr
        - ii. EAC will propose to approve \$200 from their budget to have total to buy herbicide.
    - 3. Parks and Rec recommends that the BOS plan for Autumn/Russian Olive shrub removal in PCP along the creek near new tree planting. (Between Memorial Garden and Disc Golf Basket 1)
      - a. Please note that Open Space Committee may have the ability to add this project to their Track Invasive Species project.
