Mr. Hallman drew Board members and the public to Governor Shapiro's Housing Executive Order to meet Legislative statewide zoning announced last week. Specifically, members of the

State House and Senate claimed that local government land use policies have helped cause an “affordable” housing shortage. Mr. Hallman asked Mr. Romano to share the leadership’s concerns regarding this executive order with other Township Managers and both State and Senate House Representatives.

NEW BUSINESS

The Parks & Recreation Committee requests to purchase and plant bushes in Pine Creek Park Playground: Ms. Mifsud made a motion to approve the planting of bushes in Pine Creek Park Playground. Mr. McLewee seconded the motion. The motion passes unanimously.
